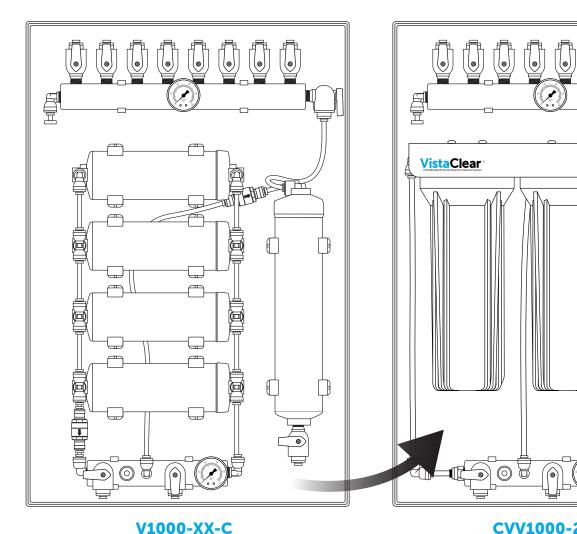

The VistaClear<sup>TM</sup> HP Centralized Water Filtration System is designed to provide centralized backflow prevention and micron-level filtration for water used for general dentistry applications including irrigation, cooling, lubrication and scaling procedures.

A DentaPure<sup>™</sup> Cartridge is provided with the CVR9280. The DentaPure Cartridge reduces microbial contamination from the procedural water supplied through the instruments to meet water quality having <200 CFU/mL.

It is important never to use water from a standard dental delivery system during surgical procedures. Instead, use sterile water or saline delivered by sterile means, such as autoclavable bulb syringes, or autoclavable or disposable sterile tubing (per CDC MMWR Guidelines for Infection Control in Dental Health-Care Settings – 2003).

Read this manual thoroughly and keep it with your original system manual permanent records after installation. Use this new manual as a reference guide for your routine maintenance. Return your warranty registration form or register online immediately upon installation and contact your distributor with any questions you may have.

#### **Warranty Notice:**

Your additional warranty coverage included with your new Retrofit System covers only the new components provided in this conversion kit as your original system warranty may have expired. Please note the new serial number and record all information on the back of this manual. Also refer to the warranty information included on page 11 of this new manual.

## Special Notices, Warnings & Reminders

To ensure that your new system provides many years of trouble-free service, please observe the following:

- 1. Read the complete Installation Guide & Owner's Manual to completely understand the installation, maintenance, capabilities and limitations of the system.
- 2. We strongly recommended that plumbing required for this system be done by a trained, authorized professional contractor who is familiar with all local codes working in conjunction with an authorized dental dealer technician. See page 4 for system plumbing specifications.
- 3. Both filter elements should be changed at least once per year or after every 2,400 liters of use, which ever occurs first.
- 4. All VistaCheck™ Dual Check Valve Backflow Preventers downstream of the Distribution Manifold on the system should be checked at least once per year to make certain they are working properly. Follow the steps outlined in your original system manual to perform this simple but important testing procedure. This is best done while changing the filter elements.

#### 5. Bypassing the System:

Every system comes configured with the ability to bypass the filtration elements during emergencies and/or required system maintenance or repair during business hours.

- A. The red bypass line tubing is provided but never "connected" by the manufacturer.
- B. The bypass line should never be "connected" during general installation.
- C. If the system is ever bypassed for any reason, it should be bypassed for only as long as is necessary to accomplish the maintenance or repair and disconnected as soon as possible.
- D. If the system is ever bypassed for any reason, a complete system cleansing procedure should be performed as described on page 9.
- 6. The system should never be operated unless filter elements are installed in their proper location.
- 7. Remember to complete and return the warranty registration form or register online immediately upon installation. It is very important that we receive your registration so that we can 1) place your name in the national systems registry, 2) send you a reminder

to change your filter elements and test your backflow preventers, and 3) notify you of improved, streamlined maintenance procedures or new line cleaning agents.

#### **Important Product Information**

The VistaClear™ HP Centralized Water Filtration System is a complete manufactured assembly for process water. The system is used for filtering water for use during patient care in dental operatories while also serving as a backflow prevention device.

Each system includes CSA certified VistaCheck™ Dual Check Valve Backflow Preventers for use on the compressed air and potable water inlets and each treated water outlet; air and water pressure regulators; specialty water treatment filters; air gap drain fitting; control and distribution manifolds; pressure gauges; a mixing chamber, injection port and threaded plug for the administration of periodic cleaners and antimicrobials; and, 1/4" O.D. tubing, fittings and valves. The system is to be installed by a trained dental equipment technician and/or suitable plumbing subcontractor and maintained by trained dental staff.

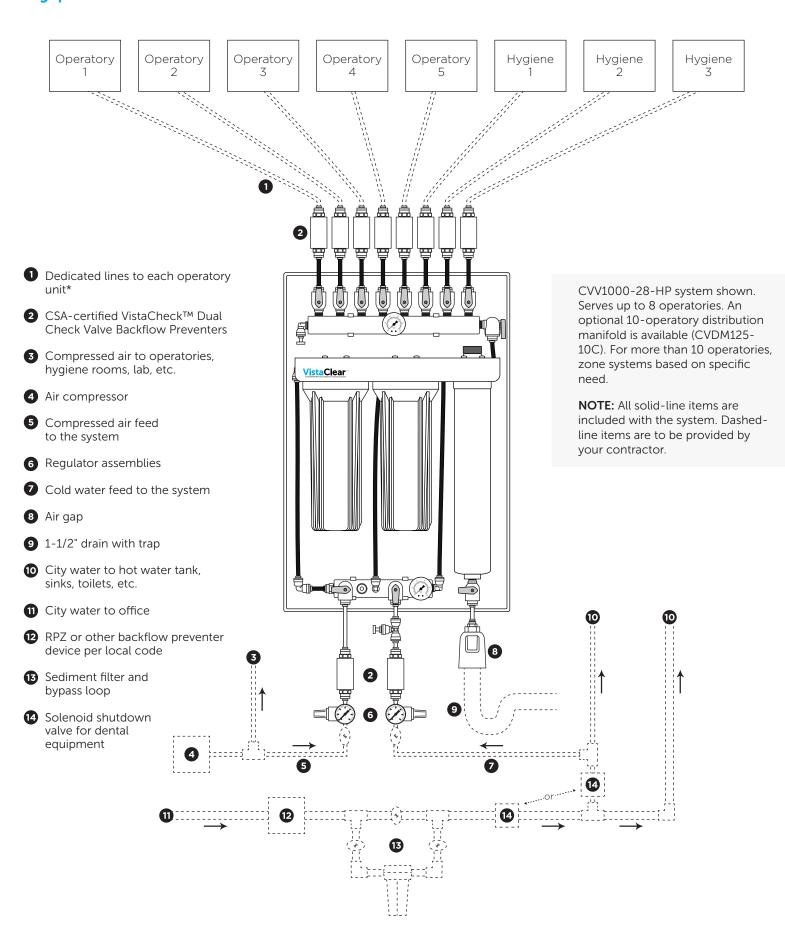
#### Please Note:

Use of a VistaClear™ HP Centralized Water Filtration System does not, by itself, eliminate the need for proper user maintenance. Due to the nature and complex design of dental delivery units, the periodic use of antimicrobial waterline cleaners is extremely important for proper dental waterline care.

According to the CDC, even sterile water introduced to a typical dental delivery system can be contaminated quickly due to a combination of factors, including: low-volume, slow flow rates; the use of small-diameter tubing that contributes to laminar water flow; acquiescence to room temperature; and the use of quick-connect fittings, handpieces and other devices that can introduce contamination from the environment to the waterlines.

While DentaPure™ Cartridges do not require monitoring, Crosstex supports all recommended/ required monitoring guidance. Should microbial water quality ever exceed 500 CFU/mL, the waterlines should be flushed and treated with an approved antimicrobial cleaner.

#### Typical Tools & Supplies Required:

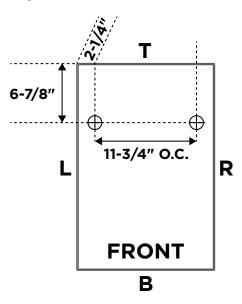
- Hammer
- Drill
- Pilot drill bit (1/16" 3/32")
- White spackling compound
- 5/16" wrench
- Tape measure & pencil



It's a good idea to lay a small towel under the system to catch any drops of water during the upgrade process.

- 1. First, close the water inlet valve on the lower manifold.
- 2. Turn off the supply valve on the right end of the upper manifold by turning it 90 degrees away from the board.
- 3. Open the drain valve at the bottom of the mixing chamber, then open the air valve to purge the remaining water from the system. Close the air valve when water stops running to the drain.
- 4. Close the drain valve at the bottom of the mixing chamber.
- 5. Remove all of the tubing in the center of the system from the filters. Simply push in on the collets of the push-to-connect fittings, then pull out the tubing.
- 6. Remove all of the horizontally mounted filter elements from the white clips and discard. Depending on the model, there will be two, three or four filters on a legacy central system.
- 7. In a similar fashion, remove the tubing from the mixing chamber, then remove the mixing chamber from the white clips on the system board.
- 8. Remove all white filter clips and screws from the system board.
- 9. Gently pound down any screw burrs remaining on the holes and fill them with white putty or spackling compound.
- 10. Now that your system board is cleared, mark the locations where you'll drill two new holes for mounting the bracket. Starting from the left side,

the first hole should be 6-7/8" down from the top edge of the board, and 2-1/4" in from the left. Mark the location of the second hole 11-3/4" to the right of the first hole, also 6-7/8" down from the top of the board.

- 11. Before drilling your pilot holes, double check your hole locations and make sure the marks you just made line up with the holes on the new bracket.
- 12. Drill pilot holes with a 1/16th or 3/32nd inch drill bit.
- 13. Install both of the provided hex-head washer mounting screws. Stop or back off the screws to allow a gap of about 1/8" between the screw head and the board.
- 14. Carefully remove both filter sumps from the new filter manifold, but do NOT remove the mixing chamber from the bracket. Be very careful not to drop the sumps, as the filter elements inside are fragile.
- 15. Hang the filter bracket on the two screws and tighten with a 5/16" open-end or adjustable wrench.
- 16. Transfer the filter serial numbers from the outside of each filter to the record table on the back page of the included retrofit manual.
- 17. Remove the labels and plastic wrap from both filters. Try not to touch the surface of the ceramic filter, or wear clean gloves. Check for cracks in the

- surface of the filter elements, and do NOT install if you discover any cracks.
- 18. Carefully lower the filters into their respective filter sumps, making certain the open-ended cap is "up" in the housing. See Instructions for Use included with the DentaPure™ Cartridge for correct filter and cartridge locations.
- 19. Carefully thread the sumps onto the manifold, making sure that the filter element with netting is installed in the right sump and the white ceramic filter element is installed in the left sump, as you're looking at the system board. Be sure not to crossthread the sumps, and hand-tighten only. The supplied sump wrench should not be used to tighten the sumps—only to help remove them.
- 20. Pull the control manifold out of the two small white clips near the lower edge of the system board, then remove the elbow adapter from the left end of the control manifold. Pull the male adapter check valve off the short piece of tubing on the new assembly and thread it firmly into the left end of the control manifold. Turn with a wrench to tighten until only about two threads are still visible.
- 21. Now reconnect the tubing to the control manifold. Plug the 1/4" O.D. tubing back into the check valve you just tightened. Plug the center 1/4" tubing into the elbow adapter on the center of the control manifold. Finally, turn the elbow adapter on the right end of the control manifold clockwise so it points upward, then plug in the right 1/4" tubing. Snap the control manifold back into the clips.
- 22. Plug the tubing coming from the mixing chamber at the top, right side of the new bracket into the valve on the right end of the distribution manifold at the top edge of the system board.

- 23. Reconnect the drain line tubing to the bottom of the new mixing chamber.
- 24. Check all connections to make sure they are tight. Refer to the photo or drawing of the HP system as a guide to make sure the new system is connected correctly.
- 25. Turn on the water supply by turning the blue handle on the water valve on the lower control manifold. Water will start to flow into the filter housings.
- 26. Open the drain valve on the bottom of the mixing chamber, allowing air to be purged from the system. Once water has filled both filter sumps, water from the filters will begin to flow to the drain. Allow the water to run to the drain for five minutes.
- 27. Close the drain valve on the mixing chamber and check the system for any leaks. If a leak is detected, immediately turn off the water supply and open the drain valve on the mixing chamber to relieve the water pressure. Attend to the leak, then repeat the steps to check for additional leaks.
- 28. If all connections are leak-free, begin a complete purging and cleaning of the system, as described in the included instruction manual and in an instructional video available online at vrg.support. This will ensure all lines are clean and ready for use.

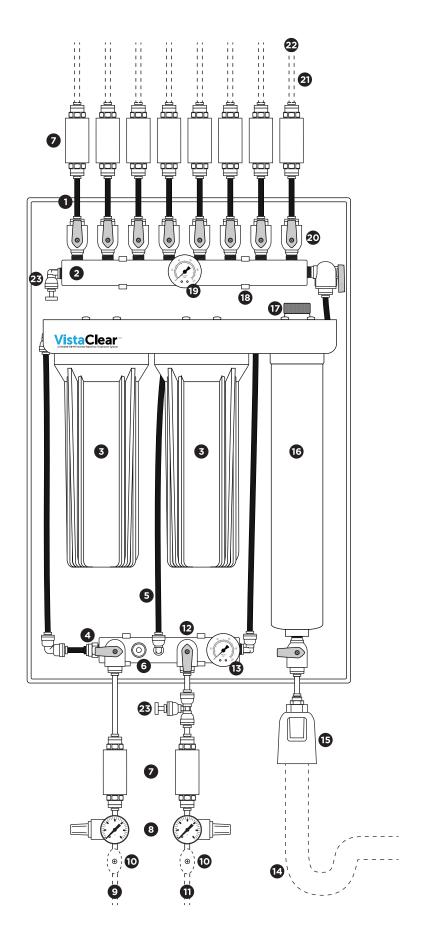

## System Maintenance

As with any piece of equipment, proper installation and maintenance of your VistaClear™ HP Centralized Water Filtration System is critical. After installation, the dental waterlines will need to be cleaned to remove any contamination following the "Purge & Clean" procedure outlined on page 9 twice. The installer or service technician should perform the initial line cleaning.

#### **DAILY**

Refer to the DentaPure<sup>TM</sup> Cartridge IFU packaged with the cartridge for directions for daily use following installation. These directions are also available at Crosstex.com.

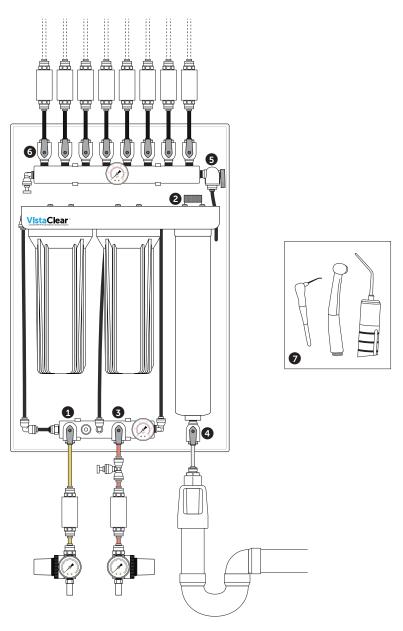
- Discharge all water-bearing lines at the beginning of each work day for a minimum of two (2) minutes.
   This should include all handpiece, syringe and quickdisconnect lines with handpieces and tips removed.
- Purge all water-bearing lines for a minimum of 20-30 seconds after each patient.

#### **ANNUALLY**

Change Carbon Block Filter and DentaPure Cartridge as outlined on page 10. For your convenience, a two-element annual replacement kit is available from your dental dealer by ordering part number CVR365HP (R365HP).

Test VistaCheck™ Dual Check Valve Backflow Preventer valves as outlined on page 12. Perform "Purge & Clean" procedure outlined on page 9 only upon initial system installation and if water test results ever show >200 CFU/mL.

## Purge & Clean Procedure

#### Step 1: Purging the System & Waterlines

- 1. Close the water inlet valve 3.
- 2. Slowly open the drain valve 4.
- 3. Open the air valve 1.
- 4. Close the drain valve 4 when water stops running to the drain.
- 5. Discharge all dental appliance lines 7 in each operatory into sink, cup or bucket until all water is evacuated and air emerges. Begin by discharging the quick-disconnect fitting on the delivery unit, if present, to speed the process considerably.
- 6. Close the air valve 1.
- 7. Open the drain valve 4 to relieve all pressure from the system.
- 8. Close the drain valve 4.
- 9. Close all operatory valves **6**.

#### **Step 2: Adding Line Cleaner**

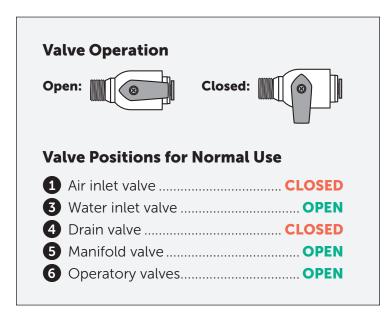
You will need to follow this procedure for each operatory, one at a time. Never attempt to add cleaner if there is pressure on the system!

- 1. Remove the mixing chamber cap 2 from the top of the mixing chamber.
- 2. Add one VistaTab™ Dental Waterline Cleaner Tablet\* to the chamber and thread the cap back into place. (Please consult tablet instructions for use and use two tablets per operatory for initial cleaning after system installation.)
- 3. Open the water inlet valve 3 to fill the mixing chamber with water to dissolve the tablet.
- 4. Close the water inlet valve 3 when the two gauges read the same pressure and the mixing chamber is full. Wait at least two minutes for the tablet to dissolve completely.
- 5. Open the air inlet valve 1.
- 6. Open one of the valves 6 for the operatory to be treated.
- 7. Go to the operatory and discharge all dental appliance lines 7 in that operatory into sink, cup or bucket until all air is evacuated and cleaning solution emerges from each appliance line, then stop. Again, start with the quick-disconnect fitting on the delivery unit to speed the process.
- 8. Return to the central system board and close the air valve 1.
- 9. Open the drain valve 4 to relieve all pressure from the system and both system pressure gauges read zero, then close the drain valve 4.

Repeat Steps 1–9 for all remaining operatories (one operatory at a time) and allow the solution to remain in the water lines for at least five minutes.

#### **Step 3: Line Rinsing Procedure**

- 1. Slowly open the air valve 1.
- 2. Slowly open the drain valve 4 to remove remaining cleaner from mixing chamber.
- 3. Close the drain valve 4 when air emerges from the drain.
- 4. Discharge all dental appliance lines 7 in each operatory into sink, cup or bucket until all cleaner is evacuated and air emerges.
- 5. Return to the VistaClear™ System and close the air valve 1.
- 6. Open the drain valve 4 to relieve all pressure from the system.
- 7. Close the drain valve 4.
- 8. Open the water inlet valve 3 to fill the mixing chamber.
- 9. Return to each operatory and discharge all dental appliance lines 7 into sink or cup until all air is evacuated and clear water emerges. Rinse each line for at least 10 seconds (or a total of 500 mL of clear water for each operatory).



#### Please note:

Never flush waterline cleaner into any vacuum or drain system that contains an amalgam separator.

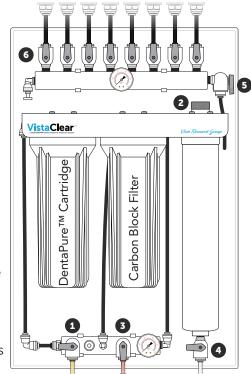
## Replacing VistaClear™ HP Filters

# DentaPure™ DP365HP Cartridge and Carbon Block Filter Installation onto a VistaClear™ CVV1000-28-HP Centralized Water Filtration System

Note: The DP365HP is a non-refillable container.

- 1. Turn off the cold-water inlet **3** on the lower manifold of the VistaClear<sup>™</sup> Centralized Water Filtration System ("system") to stop water flow to the system.
- 2. Open the drain valve 4 on the lower end of the mixing chamber to relieve pressure from the system.
- 3. Open the air valve 1 for a few seconds to purge any remaining water from the mixing chamber. Once only air is emerging from the drain valve, turn OFF the air valve.
- 4. When the pressure gauges on the system register "0," use the sump wrench supplied with the system to remove the left and center filter sumps. Support the system by holding the filter manifold while loosening the sumps.
  - a. If replacing the DP365HP Cartridge and Carbon Block Filter, remove and discard the expired cartridge/filter in the normal trash.
- 5. Wash and rinse the filter sumps. Wipe the center section of the filter caps with an alcohol wipe to clean.
- 6. Replace the O-ring in each filter sump with the supplied, pre-lubricated O-rings. Discard old O-rings.
- 7. Completely remove the plastic wrap from both the Carbon Block Filter (CVR9722) and the DentaPure™ Cartridge (DP365HP). Note the installation date to ensure replacement and the SN# on the label attached to this plastic wrap prior to discarding.
- 8. Carefully lower the Carbon Block Filter into the RIGHT filter sump, and the DentaPure Cartridge into the LEFT filter sump (see illustration), making sure the open-end caps are facing "up" in the housing.
- 9. Making certain the cartridge and filter are centered in their housings, carefully thread the sumps onto their filter caps on the manifold. Do not cross thread. Hand-tighten the sump while supporting the metal manifold.
- 10. After ensuring that both sumps have been hand-tightened, turn on the system water supply by turning the handle on the water valve 3 on the lower manifold. Water will start to flow into the filter housings.

- 11. Open the drain valve 4 on the bottom of the mixing chamber, allowing air to be purged from the system. Once water has filled both filter sumps, water will begin to flow to the drain. Allow the water to run to the drain for ten (10) minutes to flush the new cartridge.
- 12. Close the drain valve 4 on the mixing chamber and check the system for any leaks. If a leak is detected, immediately turn off the water supply and open the drain valve on the mixing chamber to relieve the water pressure. Attend to the leak then repeat the steps to check for additional leaks.
- 13. If this is the first time the DentaPure Cartridge is being installed with the VistaClear Centralized Water Filtration System (CVV1000-28-HP), begin the Purge & Clean procedure (as described in the system manual) to ensure all waterlines are clean and ready for use.
  - a. If a DP365HP cartridge has been used previously and treatment water output from dynamic instruments has remained under 500 CFU/mL, no further steps are necessary and the system is now ready for use. If CFU counts are outside of the EPA current standard for potable water guidelines, begin the Purge & Clean procedure (as described in the VistaClear Centralized Water Filtration system manual) to ensure all waterlines are clean and ready for the installation of your replacement DentaPure Cartridge.

## Limited Warranty (Retrofit System)\*

During the time period and subject to the conditions hereinafter set forth, Crosstex International, Inc. (Crosstex) will repair or replace to the original user any portion of a system which proves defective due to defective materials or workmanship of Crosstex. Contact your nearest authorized Crosstex distributor/ dealer for warranty service. At all times Crosstex shall have and possess the sole right and option to determine whether to repair or replace defective equipment, parts, or components. Damage due to conditions beyond the control of Crosstex is NOT COVERED BY THIS WARRANTY. (Contact parcel or freight company for claims on freight damaged in transit)

WARRANTY PERIOD: Crosstex shall warrant its VistaClear™ HP Centralized Water Filtration System for a period of one (1) year from the date of installation, or eighteen (18) months from the date of manufacture, whichever comes first. Filtration elements subject to varying types of water conditions are not warranted for performance due to fouling by local water conditions, but are warranted for defects in materials and workmanship.

**LABOR, ETC., COSTS:** Crosstex shall *IN NO EVENT* be responsible or liable for the cost of field labor or other charges incurred by any customer in removing and/or reaffixing any Crosstex product, part or component thereof.

THIS WARRANTY WILL NOT APPLY: (a) To defects or malfunctions resulting from failure to properly install, operate or maintain the unit in accordance with printed instructions provided; (b) to failures resulting from abuse, accident or negligence; (c) to normal maintenance services and the parts used in connection with such service; (d) to units which are not installed in accordance with applicable local codes, ordinances and good trade practices; (e) if the unit is moved from its original installation location, or; (f) if the unit is used for purposes other than for what it was designed and manufactured.

**RETURN OF REPLACED COMPONENTS:** Any item to be replaced under this Warranty must be returned to Crosstex in Phoenix, Arizona, or such other place as Crosstex may designate, freight prepaid. Write to the address listed below for a return authorization and the physical address to which items should be returned for warranty attention.

**PRODUCT IMPROVEMENTS:** Crosstex reserves the right to change or improve its products or any portions thereof without being obliged to provide such change or improvement of units sold and/or shipped prior to such change or improvement.

WARRANTY EXCLUSIONS: As to any specific Crosstex product, after the expiration of the time period of the warranty applicable thereto as set forth under the

heading "Warranty Period" above, THERE WILL BE NO WARRANTIES, INCLUDING ANY IMPLIED WARRANTIES OF MERCHANTABILITY OR FITNESS FOR ANY PARTICULAR PURPOSE.

Some states do not allow limitations on how long an implied warranty lasts, so the above limitations may not apply to you. No warranties or representations at any time made by any representative of Crosstex shall vary or expand the provisions hereof.

Alternatively, register your product online within ten (10) days of installation at **vrg.support/register**. In the absence or other suitable proof of installation date, the effective date of this warranty will be based upon the date of manufacture plus one hundred eighty (180) days.

## **Backflow Prevention**

All VistaCheck™ Dual Check Valve Backflow Preventer valves downstream from the upper (distribution) manifold of the system should be checked annually to ensure they are working properly.

## Alternative Cleaning Procedures

### Using bleach instead of VistaTab™ Dental Waterline Cleaner Tablets

Where available, we recommend using the Hu-Friedy VistaTab™ Dental Waterline Cleaner Tablets (IMS-1451) upon initial system installation and for as-needed "shock" treatments. This product is available from dental dealers throughout the United States.

However, if for some reason VistaTab Dental Waterline Cleaner Tablets are unavailable, household bleach (Sodium Hypochlorite) may be used as an alternative solution. However, it is important not to flush bleach into any vacuum or drain system that contains an amalgam separator. Also, do not leave any bleach solution in dental waterlines for more than 10 minutes.

Follow the "Purge & Clean" instructions for the system outlined on page 9, substituting the bleach solution for the VistaTab Dental Waterline Cleaner Tablet in Step 2 (Adding Line Cleaner).

- If using 8.25% bleach solution, add 2 ounces (or about 58 mL) to the mixing chamber in lieu of one (1) VistaTab Dental Waterline Cleaner Tablet.
- If using 5.25% bleach solution, add 2.5 ounces (or about 75 mL) to the mixing chamber in lieu of one (1) VistaTab Dental Waterline Cleaner Tablet.

Note that you will need to follow this process for each operatory.
