This approval supersedes the approval issued on August 15, 2014 under product file number 20140246.

This approval is contingent upon compliance with the following stipulation(s):

- These devices are intended to provide high purity water for various medical/clinical/laboratory equipment (e.g. autoclaves, dental bottles, ultrasonic cleaners, instrument washers, etc.) These devices are not intended for drinking water applications.
- Installation and maintenance of this product must be in accordance with the manufacturer's printed installation and maintenance instructions. A copy of the installation, operating and maintenance instructions shall be provided to each system owner and remain onsite.
- These devices shall be connected to municipal water supplies only.
- These devices shall discharge their wastewater to the drain system via an acceptable air gap (i.e. ASME A112.1.2 or ASME A112.1.3).
- If these devices are directly connected to autoclave, ultrasonic cleaner, instrument washer, analyzer or similar devices, then a cross connection control device suitable for high hazard shall be placed between these devices and the equipment being served.
- The waterline serving the water dispensing wand shall be protected with cross connection control device suitable for high hazard.
- These devices shall be installed by properly licensed Wisconsin Plumbers.
- These devices shall be connected to cold water supplies only.
- If the water to these devices contains significant levels of dissolved hardness, iron, manganese or hydrogen sulfide, the pretreatment of the water is strongly advised.
